The meeting will be open to the general public and will begin at 6:00 p.m. local time.

A public body may make an open call to the public during a public meeting, subject to reasonable time, place and manner restrictions, to allow individuals to address the public body on any issue within the jurisdiction of the public body. At the conclusion of an open call to the public, individual members of the public body may respond to criticism made by those who have addressed the public body, may ask staff to review a matter or may ask that a matter be put on a future agenda. However, members of the public body shall not discuss or take legal action on matters raised during an open call to the public unless the matters are properly noticed for discussion and legal action.
3. Report from the fire chief regarding the provision of fire and EMS to the CCIFD, including but not limited to the following items (CCIFD #10-n/a):
 - a) Monthly response and service report: March and April 2012.
4. Consideration of district financial matters:
 - a) Review of monthly financial reports: March and April 2012 (CCIFD #12-014).
 - b) Review of invoices / payables and authorization for payment (CCIFD #12-015).
5. Consideration of establishing a tentative revenue and expenditure budget for the fiscal year beginning July 1, 2012 and ending June 30, 2013 pursuant to A.R.S. §48-805.A.2; declaring such for publishing and public notice; and setting July 11, 2012 at 6:00 p.m. local time for a public hearing prior to adoption (CCIFD #12-016).
