## CCIFD Meeting Minutes – July 11, 2012

Invoices for payment were presented (included in board packet for May and June); PolicyLogic, LLC (\$1,646.72); Angela Bertram, CPA (\$202.50).

Motion by Hurley  $/ 2^{nd}$  by Gerber: To approve the invoices and the insurance renewal as presented for payment; Passed 3-0 (P. Coleman absent).

**Item 5:** Public Hearing in accordance with A.R.S. § 48-853.A.2: To hear taxpayer's comments on the proposed fiscal year 2012 / 2013 Chandler County Island Fire District revenue and expenditure budget (CCIFD # -n/a):

Chair Hurley opened the public hearing for comment. No public present at the meeting. Chair Hurley closed the public hearing.

Flynn reviewed revenues and expenditures with the board, along with estimates for next fiscal year end balances given the shortfall in property taxes collected by the CCIFD.

Motion Gerber / 2<sup>nd</sup> Hurley: To adopt the revenue and expenditure budget as presented as the CCIFD budget for the fiscal year beginning July 1, 2012 and ending June 30, 2013; and directing the consultant to make the required submittals and notifications as required by law; Passed 3-0 (P. Coleman absent).

**Item 7:** Consideration of engaging the firm of Angela D. Bertram, CPA for the purpose of providing the district's accounting services for the fiscal year beginning July 1, 2012 and ending June 30, 2013 (CCIFD #12-025):

Consultant Flynn discussed the annual engagement letter from the board's CPA, Angela Bertram and recommended retention of Ms. Bertram by the CCIFD.

Motion by R. Coleman / 2<sup>nd</sup> by Hurley: To retain the firm of Angela Bertram, CPA for accounting services; Passed 3-0 (P. Coleman absent).
