CCIFD Meeting Minutes - March 18, 2013

The Chandler County Island Fire District (CCIFD) governing board met in a properly posted open public meeting on Monday, March 18, 2013. Item 1: Review and approval of the governing board meeting minutes of January 9, 2013 (CCIFD #13-009):

Motion by Coleman / 2nd by Gerber: To approve the minutes of the January 9, 2013 meeting with amendments as noted; Passed 3-0.

Item 3: Report from the fire chief regarding the provision of fire and EMS to the CCIFD, including but not limited to the following items (CCIFD #13-n/a):
