

## CCIFD Meeting Minutes – July 25, 2018

---

The Chandler County Island Fire District (CCIFD) governing board met in a properly posted open public meeting on Wednesday, July 25, 2018. The meeting was held at the City of Chandler Fire Department Administrative Offices, located at 151 E. Boston Street, Chandler, Arizona.

The following agenda items were considered at the meeting:

- A. The meeting of the CCIFD board was called to order at 6:20 p.m. by Chair E. Hurley.
- B. Roll Call: Chair E. Hurley and members K. Hasper, E. Lu and J. Young. (Absent: Clerk – J. Gerber)

**Item 1:** Review and approval of the governing board meeting minutes of May 9, 2018 (CCIFD #18-023):

Motion by Hurley / 2<sup>nd</sup> by Lu: To approve the minutes of the May 9, 2018 meeting as submitted; Passed 4-0. (Absent – Gerber)

**Item 3:** Report from the fire chief regarding the provision of fire and EMS to the CCIFD, including but not limited to the following items (CCIFD #18-n/a):

- a) Monthly response and service report: May and June 2018.

Chief Dwiggins provided the board with a summary of the May and June response reports into the county islands and answered general questions concerning information contained within the reports.

- b) Chief Dwiggins stated that the Chandler Fire Department will have an ISO rating of 1, which is the best a fire department can receive. This should positively affect the insurance rates for homeowners.

The new training facility expansion is complete. The board can hold a future meeting there, if desired.

Fire Station #1 is now open.

This is the 20<sup>th</sup> year the Chandler Fire Department is starting accreditation.

b) Review of invoices / payables and authorization for payment (CCIFD #18-025):

Invoices for payment were presented (included in board packet for May and June; PolicyLogic, LLC (\$1,739.95); Angela Bertram, CPA (\$540.00).

Motion by Hurley / 2<sup>nd</sup> by Young: To approve the invoices as presented for payment; Passed 4-0. (Absent – Gerber)

Administrative Manager Vaughn updated the board on phone messages received and the disposition of messages and any follow up required.

Administrative Manager Vaughn reviewed the budget documents provided within the board packets and discussed the final proposed budget for FY 18/19. Vaughn answered general questions from the board regarding the budget. Please refer to the Revenue & Expenditure Budget document in the packet. The contract cost from the City of Chandler was relatively flat. The proposed tax rate will be 1.6333 down slightly from last year's 1.6692 tax rate.
