CCIFD Meeting Minutes - July 24, 2019

The Chandler County Island Fire District (CCIFD) governing board met in a properly posted open public meeting on Wednesday, July 24, 2019. The meeting was held at the City of Chandler Fire Department Administrative Offices, located at 151 E. Boston Street, Chandler, Arizona.

Chief Dwiggins provided the board with a summary of the May and June response reports into the county islands. Chief Dwiggins reported that it was busy across the month of May. In June, there was a low risk fire at a transfer station. In a few weeks, the staff will be going to Atlanta to try to get accreditation.

Administrative Manager Vaughn updated the board on phone messages received and the disposition of messages and any follow up required.

Item 7: Consideration of fully adopting estimates of revenues and expenditures for the fiscal year beginning July 1, 2019 and ending June 30, 2020 and declaring such to be the budget of the Chandler County Island Fire District (CCIFD #19-032)

Administrative Manager Vaughn reviewed the budget documents provided within the board packets and discussed the final proposed budget for FY 19/20. Vaughn answered general questions from the board regarding the budget. Please refer to the Revenue & Expenditure Budget document in the packet. The contract cost from the City of Chandler was up slightly (\$931,379 TY vs \$923,790 LY). The proposed tax rate will be 1.5954 down slightly from last year's 1.6333 tax rate. In addition, there was around \$20K in property taxes that was not paid from CCIFD residents. It's possible that money will be paid in the fiscal 19/20 tax year.

Administrative Manager Vaughn discussed the annual engagement letter from the board's CPA, Angela Bertram and recommended retention of Ms. Bertram by the CCIFD.
