Administrative Manager Vaughn provided an overview of the insurance services proposal by VFIS that had been distributed to each board member. There was a general discussion by the board concerning various components within the VFIS insurance proposal. Vaughn answered general questions from the board regarding the proposal. The insurance renewal came in at \$23,772 (the expiring premium was \$23,411 and the budgeted amount is \$24,000).
