Chief Chapman provided the board with a summary of the March and April response reports into the county islands and answered general questions concerning information contained within the reports. There was a fire at a transer station in March and April saw standard EMS calls.

Administrative Manager Vaughn discussed the proposed budget for FY 21/22 and answered general questions from the board regarding the budget. The contract cost from the City of Chandler was minimal. The contract costs went from \$945,829 to \$945,371. There were no other significant changes. The board discussed keeping the Real & Secured Property Taxes at \$800K. The proposed tax rate is 1.4926. These numbers may change slightly once the final fiscal year numbers are in from June 30th.
