**Item 7:** Consideration of fully adopting estimates of revenues and expenditures for the fiscal year beginning July 1, 2021 and ending June 30, 2022 and declaring such to be the budget of the Chandler County Island Fire District (CCIFD #21-025)

Administrative Manager Vaughn reviewed the budget documents provided within the board packets and discussed the final proposed budget for FY 21/22. Vaughn answered general questions from the board regarding the budget. The contract cost from the City of Chandler was \$949,829, a 0.47% from the previous year. The proposed tax rate is 1.5113, with a tax levy of \$810K.

Motion to adopt the CCIFD fiscal year 21/22 revenue and expenditure budget; to establish the property tax levy at \$810,000 and the tax rate at 1.5113 for FY21/22; to authorize staff to adjust the amount of unreserved fund balance when the June 30 CCCIFD fund balance is established by the Maricopa County Treasurer; to authorize CCIFD staff to make corresponding adjustments to the contingency / financial reserve amount; and to submit the adjusted budget to the Maricopa County Board of Supervisors for the adoption of the district's tax rate and levy as required by law.
