The Chandler County Island Fire District (CCIFD) governing board met in a properly posted open public meeting on Wednesday, July 27, 2022. The meeting was held at the City of Chandler – Fire Department Administrative Offices, 151 East Boston Street, Chandler, Arizona..

Vaughn answered general questions from the board regarding the budget. The contract cost from the City of Chandler was \$963,448. The proposed tax rate is 1.4250, with a tax levy of \$800K.
