Chief Chapman provided the board with a summary of the March and April response reports into the county islands and answered general questions concerning information contained within the reports. The number of incidents in March and April were normal.

The reconciled monthly finance reports for March and April from Maricopa County were presented by Administrative Manager Vaughn and reviewed, as were the monthly financial reports prepared by the District's CPA (finance reports included in the board packet).

Administrative Manager Vaughn discussed the proposed budget for FY 23/24 and answered general questions from the board regarding the budget. The contract cost from the City of Chandler was minimal. The contract costs went from \$963,448 to \$1,117,796. There were no other significant changes. The final numbers will be presented at the July meeting. There are conflicts with the July 26<sup>th</sup> date, so the board moved the meeting to Thursday, July 20<sup>th</sup>. The proposed tax rate will be 1.5413, slightly up from 1.4250 in FY 23.
