

CCIFD Meeting Minutes – March 12, 2025

March 12, 2025

The Chandler County Island Fire District (CCIFD) governing board met in a properly posted open public meeting on Wednesday, March 12, 2025. The meeting was held at the City of Chandler – Fire Department Administrative Offices, 151 East Boston Street, Chandler, Arizona.

1. CALL TO ORDER

The meeting of the CCIFD board was called to order at 6:02 p.m. by Chair Gerber.

Item 1: Review and approval of the governing board meeting minutes of January 29, 2025 (CCIFD #25-005):

Motion by Hasper/ 2nd by Lu: To approve the minutes of the January 29, 2025 meeting as submitted; Passed 3-0. (Absent – Saenz)

Item 3: Report from the fire chief regarding the provision of fire and EMS to the CCIFD, including but not limited to the following items (CCIFD #25-n/a):

Motion by Lu / 2nd by Gerber: To accept the financial reports as presented; Passed 3-0. (Absent – Saenz)

b) Review of invoices / payables and authorization for payment (CCIFD #25-007):

Invoices for payment were presented (included in board packet for January and February; PolicyLogic, LLC (\$2,055.46); Angela Rath CPA (\$475); SC Audit & Accounting (\$3,300).

Motion by Lu/ 2nd by Hasper: To approve the invoices as presented for payment; Passed 3-0. (Absent – Saenz)

Item 5: Review and consideration of the annual financial review for fiscal year 2024 conducted pursuant to A.R.S. §48-803.E (CCIFD #25-007.1).

Consultant reviewed the fiscal 2024 financial review (included in board packet) with the board and answered general questions concerning the various components of the financial review. Consultant advised the financial review had been submitted to the Clerk of the Board of Supervisors and the County Treasurer as required.

Motion by Gerber/ 2nd by Lu: To accept the financial review as presented; Passed 3-0. (Absent – Saenz)

Item 6: Consideration on renewing the district’s general liability and associated insurance and policies with Brown and Brown Insurance - VFIS of Arizona (CCIFD #25-008):

Administrative Manager Vaughn provided an overview of the insurance services proposal by VFIS that had been distributed to each board member. There was a general discussion by the board concerning various components within the VFIS insurance proposal. Vaughn answered general questions from the board regarding the proposal. The insurance renewal came in at \$29,893 and the budgeted amount is \$30,000).

Motion by Gerber / 2nd by Hasper: To approve renewing the district’s general liability and associated insurance and policies with VFIS of Arizona for \$29,893; Passed 3-0. (Absent – Saenz)
